## Pistons & Paws' Tenterden Lions Classic Vehicle & Dog Show

### REGULATIONS FOR TRADERS & EXHIBITORS

1. All entries are at the discretion of the organisers. Completion of the application form does not guarantee acceptance due to space limitations.
2. All vehicles are accepted into the show field and event on condition that the show organisers cannot be held responsible for exhibitors' or traders' negligence which may cause damage or injury to vehicles, persons or property. Similar for loss or theft of vehicles, contents and equipment. Traders must ensure they have public liability insurance cover.
3. Exhibitors are responsible for their own risk assessment and implementing suitable and sufficient control measures throughout the event. A copy of your Risk Assessment should be provided to the organisers.
4. It is the responsibility of the Exhibitors/Traders to ensure that all vehicles being driven on the showground have as a minimum third party insurance cover. Road Traffic act rules apply on site.
5. Vehicles entering and leaving the showground are restricted to maximum of 5 mph and no unauthorised movement of vehicles is permitted during show time until after 4:30 pm.
6. Any emergency vehicles needing to leave earlier must contact a show marshal before moving. You will then be escorted from the showground.
7. Dogs are allowed on site but must be kept under control and on a leash at all times. Pets are the direct responsibility of their handlers. No dogs are to be left in cars or show organisers will remove them.
8. The riding of cycles, motorcycles, quad bikes etc. on the showground is strictly forbidden at any time, except when accompanied by a marshal.
9. The sale of any form of weaponry or knives is strictly forbidden.
10. The organisers and marshals reserve the right to remove anyone from the showground who is considered to have contravened the regulations and could result in a ban for the individual/club/trader from future shows.
11. All generators must have residual circuit breakers and earth rods and be sited not to cause injury or disturbance to adjacent exhibitors or visitors.
12. To comply with health and safety regulations, all portable appliances and extension leads must have a current annual test certificate of safety.
13. Traders selling food must comply with all relevant Environmental Health Food Regulations. It is their responsibility to ensure that this is complied with and copies should be provided to the organisers.
14. All Traders are responsible for leaving their pitch clean and litter free. Please use the skip in the Arena Field.
15. By completing your Entry Form, it is deemed that you accept the above regulations.
